

## **PRIVACY STATEMENT**

For the visitors of the website [www.taksofonas.lt](http://www.taksofonas.lt), participants of the final work "Things I didn't dare say and it is now too late" of the Lithuanian National Opera and Ballet Theatre and "Operomanija's" project "Opera Genome"

### **Who is the manager of your personal data?**

Lithuanian National Opera and Ballet Theatre (hereinafter – the Theatre), legal entity code 190753881, address A. ### **For what purposes and under what conditions will the processing of your personal data be carried out?**

The personal data of the visitors of the website [www.taksofonas.lt](http://www.taksofonas.lt) participating in the final work of the project "Opera genome" "Things I didn't dare say and it is now too late" (hereinafter – the project) are processed for the purpose of participation in the project.

Once you have decided to participate in this project, the processing of personal data for the purposes of the project is carried out in accordance with Article 6 (1) (f) of the General Data Protection Regulation (EU) 2016/679 – the processing is necessary for the legitimate interests of the manager or third party, unless such interests or fundamental rights and freedoms of the data subject are necessary to ensure the protection of personal data and take precedence over them.

### **Which personal data is being processed?**

Please be informed that the following personal data of you will be processed during your participation in the project: personal voice (audio) recording; IP address.

We emphasize that your participation in the project is voluntary, so you do not have to participate in it. If you decide to participate in the project, you must then provide your personal data mentioned above, without which the data manager will not be able to allow you to participate in the project properly.

### **Who will have access to your personal data and to whom will it be provided?**

The Theatre ensures that only the Theatre staff organizing, carrying out and servicing the project will get acquainted with the data provided by you during the implementation of the project.

Your personal data will be provided to the Public Institution "Operomanija" (company code 301863621) – Theatre's data manager, organizing the project together with the Theatre; it may also be provided to the IT specialists administering the project website [www.taksofonas.lt](http://www.taksofonas.lt).

We would like to inform you that in cases established by law and when the provision of personal data is necessary and proportionate for legitimate and specific purposes, your personal data may be transferred to courts or other pre-trial investigation, supervision, and other institutions.

### **What security measures are taken to protect your personal data?**

The Theatre obliges the Theatre staff and service providers to ensure the confidentiality of data and its proper protection. When processing your personal data, the Theatre applies technical and organizational data protection measures, which are set out in the “Rules for Processing Personal Data in the Theatre” placed on the Theatre website [www.opera.lt](http://www.opera.lt), in the section “Personal Data Protection”. The Theatre also follows personal data processing principles, which are set out in the Regulation.

### **How long will your personal data be stored?**

Your personal data will be processed from the beginning of the project on 01-02-2022 and for the entire period of the project until 01-06-2022.

### **What rights do you have and how do you exercise them?**

As a data subject, you have the right to contact the Theatre about matters relating to the processing of your personal data and have the following rights:

1. The right to be informed about the processing of data;
2. The right of access to data;
3. The right to have the data altered;
4. The right to have data erased ("right to be forgotten");
5. The right to restrict the processing of data
6. The right to object to the processing of your personal data (in which case you will not be able to participate in this project).

We would like to inform you that you have the right to apply to the Theatre for the exercise of your rights mentioned above. Your rights are exercised as defined in the “Description of the Procedure for Exercising the Rights of Data Subjects at the Lithuanian National Opera and Ballet Theatre” approved by the General Manager of the Theatre, posted on the Theatre website [www.opera.lt](http://www.opera.lt), in the section “Personal Data Protection”.

If you contact the Theatre with a request for the processing of your personal data and if you do not agree with the Theatre’s decision regarding the implementation of your request regarding the exercise of your rights as a data subject, you have the right to submit a complaint to the State Data Protection Inspectorate by e-mail [ada@ada.lt](mailto:ada@ada.lt).
